

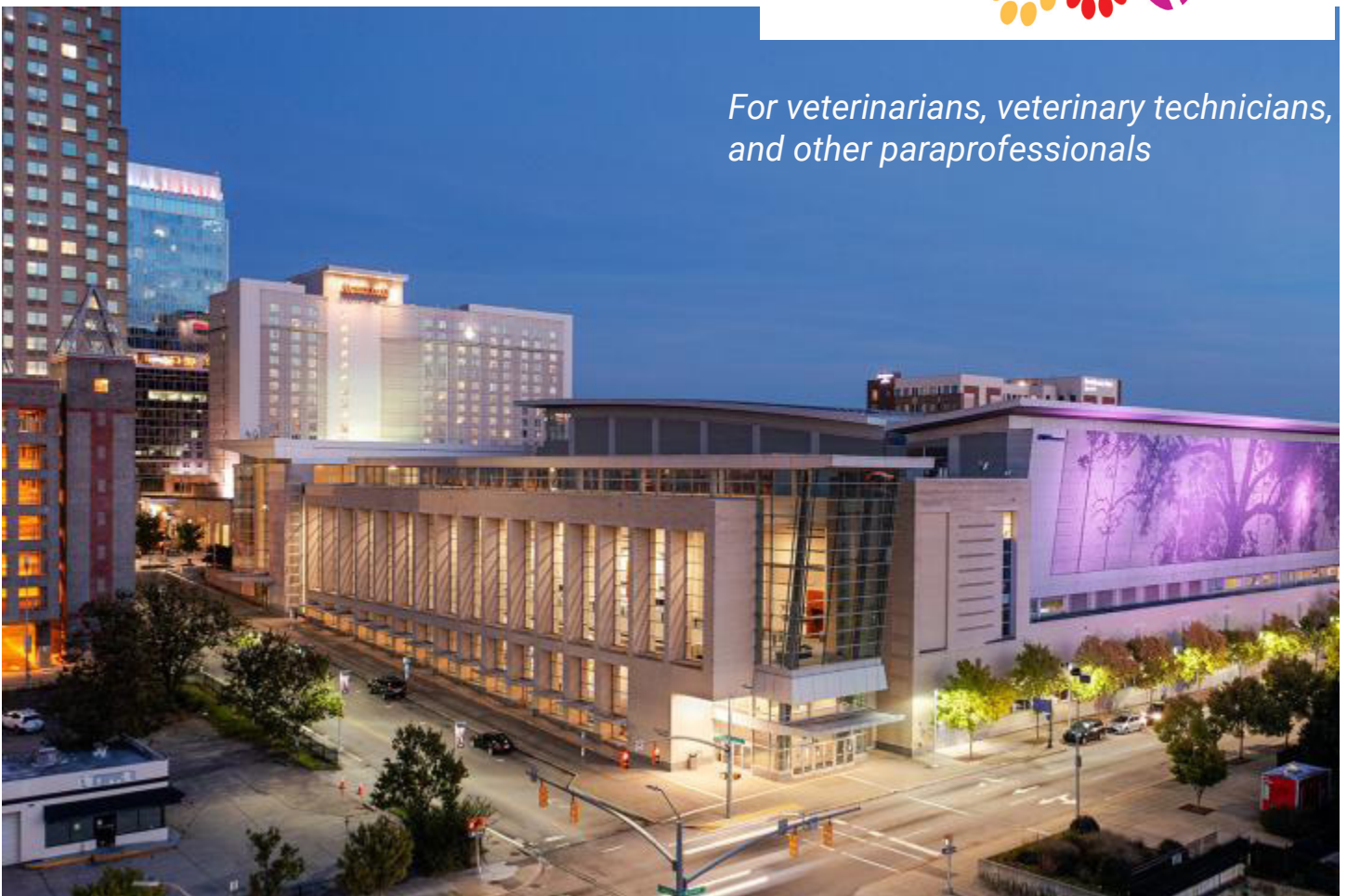
# NORTH CAROLINA VETERINARY CONFERENCE

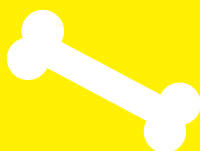
